- ❖ The member exclusively receives 20% off all additional services and 10% off all retail products.
- ❖ You may roll over your monthly treatments and hydrotherapy passes for up to 6-months with an active membership.
- ❖ If you should decide that you no longer want to be a member, any treatments and hydrotherapy passes that have been rolled over will expire at time of cancellation _____

Membership:

1. The Initial Period for the membership is 6 months. If the member wishes to cancel before completing the Initial Period they must pay back all discounts received (including hydrotherapy passes).
2. After the Initial Period, the membership will automatically continue month to month. Accounts can be frozen for up to 3 consecutive months, after completing the Initial Period of 6 months (*benefits and hydrotherapy passes are not redeemable during the membership freeze*). After freezing, member must have an active membership for 12 months before freezing again.
3. This Agreement is personal to the member and may not be assigned, transferred or otherwise disposed of by the member.
4. Applicants for membership must be at least 18 years old.

Automatic Payment Agreement:

1. Monthly membership payments shall be made in advance by direct debit from the member's designated credit/debit account. This information will be kept on file by Yuan Spa. _____
2. Yuan Spa reserves the right to review subscriptions periodically. Members will be given at least 30 days' notice in writing of any changes, which include: (i) any increase in membership fee, (ii) change in date of automatic withdrawal.

Termination or Suspension of Membership:

1. Yuan Spa reserves the right at any time to cancel or suspend the membership of any member in the event of the following:

- a. The member commits a serious breach of this Agreement and/or Yuan Spa Rules and Regulations.
- b. Where any monies are due to Yuan Spa by the member remain unpaid for 30 days after its due date for payment.
- c. The member knowingly provides false details when applying for membership and the false declaration would have reasonably affected Yuan Spa’s decision to grant the membership.
- d. If Yuan Spa terminates for any reason, they reserve the right to retain any monies received to cover any reasonable costs they have incurred as a result.

Terms and Conditions:

- 1. Yuan Spa reserves the right to vary, add or eliminate any of the particular services and facilities provided them from time to time.
- 2. Yuan Spa reserves the right to set aside facilities for social events or activities.
- 3. Yuan Spa reserves the right to close or modify facility hours with or without notice.
